FROM THE REGISTRY

Online Applications for Registrations, DNA kits and Stallion Service Reports

We are pleased to announce the launch of Online Applications for Registration which includes the ability to order DNA kits and submit stallion service reports online. In order to help facilitate this process, a new Registry Rule is in effect as of December 1, 2018 which states: "For any Application for Registration submitted online, four current color photographs, showing both sides, front and rear, must be submitted electronically to the Registry before the foal will be registered. The Registry reserves the right to reject any photos." Note that photos must show the entire horse from each side so that all markings are clearly visible. Please remove bandages, boots, mud, etc. prior to taking the photos.

Amnesty on Registry Fees

The Registry will be offering an Amnesty on Late Fees for complete Transfers of Ownership postmarked in February 2019. This means that late fees will not be assessed regardless of the Date of Sale. The \$65 Transfer fee will apply. This is a great opportunity to update recorded ownership on registered horses where the chain of ownership is not current. Note, that in order to be eligible for the amnesty rate all necessary signatures, documents and fees must be included with the original submission. In addition, if you are not in possession of the registration certificate with the gold seal, a notarized Affidavit must be submitted along with four current color photos and a \$50 fee. An Amnesty on Applications for Registration will be offered for Applications for Registration postmarked in March 2019. For all horses over the age of 12 months, a \$100 registration fee will apply. Normal registration fees are \$200 for horses 12 months to 24 months and \$300 for horses 24 months and over. Note, in order to be eligible for the amnesty rate, the sire and dam of the horse being registered must be registered with the American Saddlebred Registry and all necessary signatures, documents and fees must be included with the original submission. A separate \$50 DNA kit fee will apply.

American Saddlebred Distance Horse National Championships

The American Saddlebred Registry is joining the Arabian Horse Association in the Distance Horse National Championships Event starting in 2019. The Event will include a 50 mile American Saddlebred National Distance Championship Ride. Qualifications for the ride are as follows: The horse must be registered with the American Saddlebred Registry or with the Half American Saddlebred Registry of America. The horse must be at least 5 years old on the day of the ride. Both horse and rider must have successfully completed at least two AERC endurance rides of 50 or more miles in a day prior to the start of the Championship. Mileage does not have to be earned by the same horse and rider team entering the Championship. The Championships will be held in Vinita, Oklahoma on October 25-27, 2019.

Live Foal Report

Beginning in January 2019 owners of mares listed on a 2017 stallion service report will receive a Live Foal Report to complete and return to the Registry. The information in these reports will be beneficial as it will help determine conception rates and assist the Registry in following up on foals that are not yet registered. The goal of the Registry is to use this information to increase the number of foals being registered.





American Saddlebred Registration Trends



Foal Registration Comparison to Mares Bred




