A current American Saddlebred Horse and Breeders Association (ASHBA) competing member may transact business with the Registry of the ASHBA. A non-member of the ASHBA may transact business with the Registry of the ASHBA upon payment of a \$50 non-member transaction.

Registry of the ASHBA Rules Section III. Registration H. Names:

- Each animal for which Application for Registration is made must be given an acceptable name which does not conflict with the name of any other animal registered with the Registry of the ASHBA, living or dead. A conflicting name is one which is judged to be too similar to an existing name either in spelling or pronunciation, e.g., Black Knight/ Black Night. Adding "A", "An" or "The" to an existing name or removing "A", "An" or "The" from an existing name is judged to be too similar. The Registry of the ASHBA may consider waiving this requirement for horses with the same or similar names with a foaling date of 40 years or more prior that do not have registered progeny and are not Saddlebred Record (CH), Broodmare Hall of Fame, World Champion or Reserve World Champion horses.
- The name may not exceed 35 characters, including letters, spaces and punctuation.
- It is recommended that three name choices be provided on the application in order of owner's preference.
- The Registry of the ASHBA reserves the right to accept or reject any or all of the names submitted, whether for reasons of conflict or good taste, and also reserves the right to correct obvious misspellings.
- The following are not allowed as part of a horse's name:
 - numerical prefixes or suffixes: Numerals;
 - "Jr." and "Sr." as suffixes;
 - Diacritical marks;
 - Punctuation marks as prefixes;
 - Initials added as a prefix or suffix to a name already in use, e.g. Wing Commander G.G.
- Any available name may be reserved with the Registry of the ASHBA and will be reserved for a period of twelve (12) months. A fee of \$50.00 will be assessed for each name reservation. See Section XI. regarding Fees.
- The same person/entity that has used a name to register a horse may reuse the same or similar name, if the originally named horse is still listed in their recorded ownership and has been listed as deceased in the Registry of the ASHBA records and does not have any registered progeny or show records.
